movement; was Founder-General Secretary of the Muslim League at Hissar; arrested during the Muslim League agitation and detained in prison throughout the agitation; his house was bombed during the riots, 1947; organized the defence of Hissar Muslims during the riots for full one month; orders of arrest were issued against him and his family but managed to escape to Pakistan in disguise; settled in Multan after migration; worked for the Muslim League, was Vice-President District Muslim League, and was Vice-President, Multan Bar Association; Member of District Board, Multan; President and Secretary of Anjuman-e-Muhasin-ul-Islam, Hissar; father, Moulvi Mahboob Khan, was a Pleader at Hissar; son, Ejaz Mahboob is a student.

belongs prominent member of the Provincial Muslim League Working Committee and the Council; resigned his seat in the Legislative Assembly in December 1947 and accepted the post of District and Sessions Judge; returned unopposed as a Councillor to the Municipal Committee, Bannu, in 1933; returned unopposed to the District Board, Bannu, of which he was first Vice-Chairman and later Chairman, in 1937; was Member, Anti-Corruption Committee under the Chairmanship of Sir George Cunningham, the then Home Member; married the daughter of Khan Sahib Gul Muhammad Khan, late Senior Sub-Judge, Bannu, in 1928 and after her death to another daughter of the Khan Sahib in 1942; has three sons, Muhammad Yusaf Khan, Anwer Kamal and Akhtar Munir and four daughters.

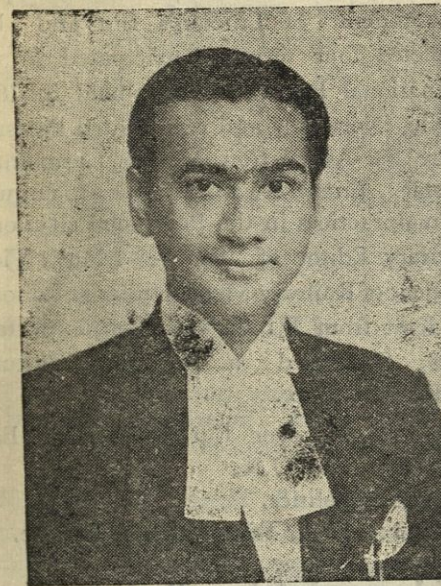

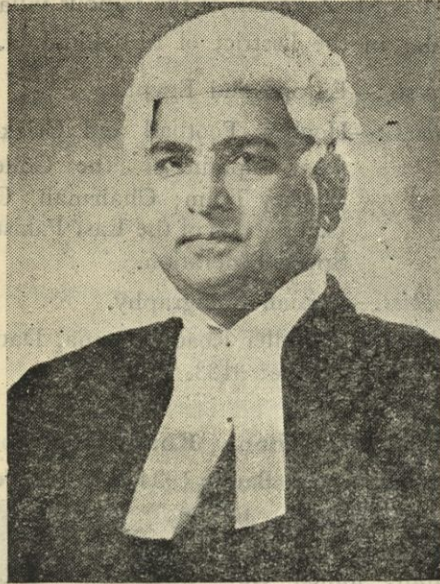
